Completed lawsuits:

- October 2018: climate lawsuit at the Berlin Administrative Court with three families from organic farms affected by the climate crisis. Although the Berlin Administrative Court dismissed the lawsuit in the first instance on October 31, 2019, it also made clear that climate lawsuits are admissible in principle - a partial success for the plaintiffs. https://www.greenpeace.de/klimaschutz/klimakrise/teilerfolg-erster-instanz (german text)

- February 2020: Nine young people file an appeal with the Federal Constitutional Court, supported by Greenpeace. On April 29, 2021, the Federal Constitutional Court confirms that the federal government's inadequate climate policy threatens the civil liberties of the young generation - a historic ruling.

Ongoing proceedings:

- November 2021: Supported by Greenpeace, four plaintiffs demand Volkswagen AG in two independent proceedings to cease worldwide production of climate-damaging internal combustion engines by the end of the decade. The Detmold and Braunschweig Regional Courts dismiss both suits in the first instance, and the plaintiffs announce that they will appeal.

- April 2023: Eight European Greenpeace country offices file a lawsuit against the EU Commission before the European Court of Justice in Luxembourg regarding the EU Taxonomy Regulation. They demand the annulment of the Delegated Act on the inclusion of nuclear and gas in the EU Taxonomy.
